### Precautions for safe handling

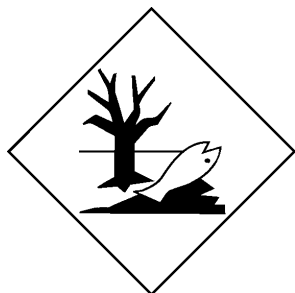
