DIRECTIONS: This product has a special valve that will spray upside down for easy use on legs, feet and hard to reach areas. Repels mosquitoes for 6 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 6 hours if necessary. Spray clothing and exposed skin except face. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat.
